Fukushima Water: Tokyo summons Beijing envoy

Japanese living in China have been urged to keep low profile

Japan summoned China's ambassador on Monday to protest against a flood of nuisance calls from China to local businesses following the release of water from the Fukushima nuclear power plant.

Deputy Foreign Minister Masataka Okano told ambassador Wu Jiahua that China should properly inform the public "rather than unnecessarily raising people's concerns by providing information that is not based on scientific evidence", the foreign ministry said in a statement.

Last week, China banned all seafood imports from its neighbour after Japan began releasing cooling water from the stricken Fukushima plant in an operation that Tokyo and the UN's nuclear watchdog have said is safe.

Since then, apparently randomly chosen Japanese businesses ranging from bakeries to aquariums have received reportedly thousands of sometimes abusive crank calls from Chinese numbers.

Social media users in China have posted recordings

"There have been numerous phone calls regarding the discharge that are suspected of originating from China. The situation has not improved since then," Okano told Wu

and videos of these calls, some of which have attracted tens of thousands of likes and a large number of comments.

"Since the start of the discharge, there have been numerous phone calls and other harassment regarding the discharge that are suspected of originating from China. The situation has not improved since then," Okano told Wu.

"A number of similar incidents are also happening in China against Japan-related facilities. This is extremely regrettable and we are deeply concerned," he said, according to the release.

Japan's embassy over the weekend urged the tens of thousands of Japanese living in China to keep a low profile

and not talk loudly in public. On Monday, it said it had increased security measures outside Japanese schools and diplomatic missions in China.

According to Japanese media, there have been several incidents of stones and eggs being thrown at Japanese schools. Japan has begun releasing more than 500 Olympic swimming pools' worth of wastewater from Fukushima into the Pacific, 12 years after a tsunami knocked out three reactors in one of the world's worst atomic accidents.

Plant operator TEPCO says that all radioactive elements have been filtered out except for tritium, levels of which are within safe limits.

Japan scrambles jet after Chinese military drone spotted near Taiwan

Japan's defence ministry said on Monday it scrambled a fighter jet to monitor a Chinese BZK-005 military drone spotted flying between Japan's westernmost Yonaguni island and Taiwan in the morning.

The spy drone came from the East China Sea north of Taiwan and went to Bashi Channel that separates Taiwan's southern coast and the Philippines, it said. On Friday, Japan also scrambled its Air Self-Defense Force fighters to Chinese bombers flying near Japan's Okinawa island, home to a major US military base, as well as to drones spotted near self-ruled Taiwan.

American Airlines fined \$4.1 million

WASHINGTON: The federal government is fining American Airlines \$4.1 million for dozens of instances in which passengers were kept on board planes without a chance to exit during long ground delays. The US Department of Transportation said on Monday it is the largest such fine against an airline since rules covering long ground delays took effect about a decade ago. The department said its investigation revealed that from 2018 through 2021, American kept 43 domestic flights stuck on the ground for at least three hours without giving passengers the chance to deplane.

Pak human rights lawyer re-arrested

ISLAMABAD: Pakistan police re-arrested human rights lawyer Imaan Mazari outside the Adiala Jail in Rawalpindi on Monday, hours after an Islamabad anti-terrorism court granted her bail in a sedition case. Confirming the arrest, the police said Imaan was arrested in a terrorism case registered at Bara Kahu police station. The arrest comes hours after Islamabad court granted Imaan and former lawmaker Ali Wazir post-arrest bail against surety bonds of Rs 30,000 each.
